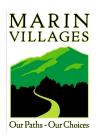



COVID-19 UPDATE



Are you one of the 49,000+ people in Marin who have received at least one vaccination shot, or the 22,000+ who have received two vaccination shots against COVID-19? We certainly hope so! The County and Marin healthcare providers have made a concerted effort to vaccinate adults 75 and over and are now beginning to offer appointments to those 65 and older. Early access to the vaccines is one of the benefits of being older. Lots better than a discount at the movies or the ferry to SF!

Despite confusing information on availability and unfortunate difficulties with scheduling, vaccinations are continuing in Marin, as well as in surrounding areas. Alas, weather delayed some vaccine deliveries to the County at the end of last week, requiring some rescheduling of previously scheduled appointments and delays in new scheduling through Marin Public Health. Different healthcare providers (MarinHealth, Sutter, Kaiser, Medical One, Marin Community Clinics) may also have been temporarily affected. Near term, Rite Aid and CVS appointments were also affected. But, "scheduling delayed" doesn't mean "scheduling over." Check the County Public Health website for the latest information. It is the most consistently reliable source for

information on when and where vaccines are available and how to schedule.

If you haven't yet been able to get an appointment, keep trying! If you get discouraged or need assistance, Marin Villages volunteers may be able to help. Check with the office. (415) 457-4633 or info@marinvillages.com

Are you concerned about whether there are risks to getting vaccinated? Check out this handy document from Marin Public Health that provides really helpful factual, data-driven information and debunks some myths you might have heard floating around in the community.

Don't forget: Wearing masks, social distancing, avoiding indoor gatherings and washing your hands remain important whether or not you are vaccinated! We are not at herd immunity yet.
